Who are we looking for?

We are looking for a young, dynamic student, specialised in dairy industry, to support KDDC on developing and operationalise the concept of good management inside their dairy factory.

Context

Kamdhenu Dairy Development Cooperative (KDDC) is located in Itahari, Eastern Nepal. The cooperative was established in August 2000 and has started milk processing in 2003. KDDC has created a new processing facility with capacity more than 30,000 litres daily mainly because of two reasons. Firstly, the cooperative can process more milk coming from their members in this new factory. Secondly, the current factory is situated in a densely populated area in the city, which lead to congestion and complaints from neighbours. While shifting to the new factory, the cooperative aims to improve their practices and the quality of the dairy products. The cooperative is looking for an intern to help them to improve this process.



The assignment

- Review a format for recording and operationalise it during his/her stay.
- Support in following and improving the operational manual for production and cleaning process.
- Support in analysing the recorded information from the production department.
- Feedback to the respective department after analysing the data.

Profile of the intern

Knowledge: on good management practice inside food processing factory

Experience: on working inside any food processing facilities

Competences: on record keeping, managing data and analysis, giving feedback

Language level: English
